RE: Two Minor Amendments to the 3rd Generation Bassett Creek Watershed Management Commission (BCWMC) Plan

Dear Chairman Welch:

The Board of Water and Soil Resources received documentation requesting approval of two changes to the 2004 BCWMC Watershed Management Plan via minor amendments dated June 26, 2007. The Northwood Lake East Pond project proposes to increase the original cost estimate for the design and construction of the water quality treatment pond based on results from the project feasibility study. The other requested amendment proposes to add the Sweeney Lake branch stream restoration project to the CIP and to add the revised Bassett Creek Flood Profiles, Table 5-3, to the Plan.

The proposed minor amendments to the Plan has been reviewed pursuant to MN Rules Chapter 8410.0140, Subpart 2 and the Board agrees these projects are consistent with BCWMC goals, policies, and implementation priorities, and therefore, does constitute a minor amendment to the Plan.
