Volunteers Explore and Study Lakes and Streams in the Bassett Creek Watershed

Golden Valley, Minnesota, September 30, 2015 – The Bassett Creek Watershed Management Commission (BCWMC) thanks its volunteers for their hard work in helping the BCWMC achieve its mission "stewardship of water resources to protect and enhance our communities." The 1968-established Bassett Creek Watershed Management Commission works to maintain and enhance the quality of lakes and streams in the Bassett Creek Watershed, which encompasses 40 square miles within nine west metro cities including: Crystal, Golden Valley, Medicine Lake, Minneapolis, Minnetonka, New Hope, Plymouth, Robbinsdale, and St. Louis Park.

Originating from the Bassett Creek Flood Control Commission formed in 1969, the BCWMC was established in 1982.
