| 1. | <u>Project</u> . The Project will consist of restoring all or portions of the main stem of Bassett Creek in Minneapolis from the Fruen Mill area to the entrance of the Bassett Creek tunnel. |
| 2. | <u>Feasibility Report</u> . The City will prepare a feasibility report for the Project (the "Report") in accordance with the Proposal from Barr Engineering attached as Attachment One. The City will provide the Commission the Report upon its completion. |
| 3. | Reimbursement. The Commission will reimburse the City up to |

- 4. <u>Reimbursement Limits</u>. Reimbursement to the City will not exceed the amount specified in paragraph 3. Reimbursement will not exceed the costs and expenses incurred by the City for preparation of the Report, less any amounts the City receives for preparation of the Report as grants from other sources. All costs of preparing the Report incurred by the City in excess of such reimbursement shall be borne by the City or secured by the City from other sources.
- 5. <u>Audit</u>. All City books, records, documents, and accounting procedures related to the preparation of a Report are subject to examination by the Commission.
