# 3. NOTICE OF PLAN TAC MEETING: December 15<sup>TH</sup>

The Plan Technical Advisory Committee includes member cities, state, regional, and local review agencies, and technical partners (like TRPD and MPRB). This group will meet December 15<sup>th</sup> (10:00 a.m. – 12:00 p.m.) to review the issues and their priority level along with all issue statements and measurable goals thus far recommended by the PSC. The intent of the meeting is to gather feedback from Plan TAC members on plan development progress and direction to date, get their ideas for addressing issues (what is working or not working in other areas of the Metro or state), and get their general "buy in" on goals and potential actions to streamline the review period. The further the PSC gets in discussing issues and goals at this meeting, the more content staff will be able to present to the Plan TAC group.

## 4. **REVIEW ISSUE STATEMENTS AND DRAFT GOALS FOR REMAINING WATERBODY AND WATERSHED QUALITY CATEGORY** – attached with meeting materials

At the last meeting the group finalized the impaired waters and chloride issues and began discussing the streambank and gully erosion issue. At this meeting, the hope is to review (and finalize to the extent possible) the remaining issues in the Waterbody and Watershed Quality category (pages 10 - 16). The attached issues and goals document includes:
